#### I. <u>CHAPTER 102 AND 105 PA DEP DELEGATION AGREEMENTS</u> ON-SITE INSPECTIONS/COMPLAINT HANDLING

1. OSI-COMPLAINT-Serridan LLC Lot Devt. (Coolbaugh)- Approximately 3/4 acre cleared and 1-3 feet of fill placed and graded. CFS installed along perimeter. IR 1 sent.

2. OSI-Follow-up- Sunset View Farm Pond/Wenola (Barrett)- Met with owner, DEP and ACE to determine restoration process for pond constructed in wetland and oversight. Corps will take lead on delineating wetland line as restoration progresses.

3. OSI- COMPLAINT- Greenwood Acres Lidio Rd Stream Crossing (Tobyhanna) - Met with POA and Management company regarding unpermitted work done on existing crossing and potential resolutions to correct inadequate crossing installation. 105 IR sent. POA to determine path forward upon cost estimates for options forward.

4. OSI- COMPLAINT- Castro Lot (Polk) -Clearing conducted on either side of stream bisecting property. Some areas near stream disturbed with no BMPs. Disturbance near 1 acre. IR 1 sent with CN. 105 IR sent for outfall to stream installed without permit.

5. OSI-Final-Middle Smithfield Library/Northeast Site Contractors (Middle Smithfield) - PCSM BMPs installed. Very nice rain garden installed in front of building. Site is stabilized. NOT acknowledged with IR 5 sent. 6. OSI- Routine- Brewskies, Main St/Marki and Sons (East Stroudsburg) -NOT inspection. Site is stabilized. PCSM BMP installation reports and proper recordation missing. IR 2 sent.

7. OSI - COMPLAINT - PCP Briarwood Fill (Coolbaugh) - Owner lined stormwater conveyance on property with clean stone. Conveyance integrity appeared to be maintained. IR 1 sent.

8. OSI - COMPLAINT - Rampola, Main (Coolbaugh) - Trees felled and stocked piled. Access road through property was covered in wood chips. Large stockpiles of wood chips in potential wetland areas. Site referred to USACE for determination. IR 1 sent.

9. OSI - COMPLAINT - Martino Upper Smith Gap Earth Disturbance (Ross) - Contractor building single family residence without E&S plan or BMPs in place. Disturbed area is less than one acre. IR 1 with CN sent.

10. OSI - COMPLAINT - Heller Shafer Fill (Hamilton) - Owner placed fill and graded property without E&S plan or BMPs in place. Disturbed area is less than one acre. IR 1 sent with CN sent.

11. OSI - COMPLAINT - Castro Shaffer Schoolhouse Earth Disturbance (Stroud) - Owner regrading property without E&S plan or BMPs in place. Disturbed area is less than one acre. IR 1 with CN sent

12. OSI-COMPLAINT-Marshals Creek Falls (Smithfield) - Lacking perimeter control BMPs. IR 1 sent.

13. OSI- Routine- West Penn Fire Co. (Chestnuthill) - Rock filters not on the approved E&S plan. Lacked visual site inspections reports. IR 1 sent. 14. OSI- Routine - Pocono Plaza (East Stroudsburg) - NPDES permit for

this site has expired. A CAP pending on this site. Additional stabilization, grading and corrections to amended soils in island areas. IR 8 sent with NOV.

15. OSI-Routine - Speed Transport (Polk) - PCSM BMPs installed. Site stabilized but additional matting required on basin emergency spillway. IR 5 sent.

16. OSI- Routine/COMPLAINT - School House Est. (Price) - lacking maintenance and E&S perimeter controls. Stockpile and access not on the approved plans. Rain gardens required additional atrium grates on outlet pipes. IR 24 sent.

17. OSI-COMPLAINT- Miller Lot Clearing, Merwine Landscaping (Chestnuthill) Contractor would not allow MCCD access, and an E&S plan was not available. IR 1 sent.

18. OSI-COMPLAINT- Transco Pipeline (Chestnuthill Tunkhannock and Hamilton) Site Lacked maintenance on E&S perimeter control BMPs and Stabilization at station 1443+95. IR 4 Sent.

19. OSI-COMPLAINT- Sr Bradford Rd. (Tobyhanna) Site Lacked maintenance on E&S perimeter control BMPs and Stabilization. IR 3 Sent.

20. OSI-COMPLAINT- Keswick Pointe (Tobyhanna) Site Lacked maintenance on PCSM BMPs. Site also lacked E&S perimeter control BMPs and Stabilization. IR 1 sent.
