#### I. <u>CHAPTER 102 AND 105 PA DEP DELEGATION AGREEMENTS</u> ON-SITE INSPECTIONS/COMPLAINT HANDLING

1. One on-site inspection, <u>Complaint</u>, Nauman Clearview Avenue Parcel Development (Stroud) - Access road and building pad installed without obtaining NPDES Permit. Potential wetland fill. Additional E&S BMP implementation needed. Site is currently in violation. MCCD Chapter 102 IR 1 with Notice of Violation and Chapter 105 IR 1 to be sent.

2. One on-site inspection, <u>Complaint</u>, Monroe County Railroad Authority Slope Failure (Paradise) - Slope below railroad track actively eroding with erosion gully extending to the Paradise Creek. IR 1 sent.

3. One on-site inspection, Technical Assistance, 234 Golf Course Road (Hamilton) - Technical assistance provided regarding Chapter 102 and Chapter 105 regulations with proposed lot improvements. No IR sent

4. One on-site inspection, Final, Aqua PA Robinhood Lakes Water System Improvements (Polk) - All areas are restored. IR4 sent with "NOT" approval.

5. One on-site inspection, Routine/Tech Assist - Willis Stockpile - Resica Falls (Middle Smithfield Twp.) - Looked at proposed stockpile areas. Identified wetland areas and provided BMP requirements to contractor for proposed stockpile areas.

6. One on-site inspection, Routine, Hideaway Hills, Lots 29-35/ RKA/ Oyer Excavating (Polk) - Lot 33 rain garden not stabilized. Lot 30 grading not per plan. Engineer raised basin 2' without revision approvals. IR4 sent w/ Compliance Notice.

7. One on-site inspection, <u>Complaint</u>, Intriago Fill Site - Pocono Forested Lands (Middle Smithfield Twp.) Approximately 3 dozen loads of fill from NJ on approximately half an acre. Fill encroaches on wetlands. 105 IR sent.

8. One on-site inspection, Routine- Pocono Forested Lands Fill Sites - Intriago site (Middle Smithfield Township) - Five lots with fill from NJ. Referred to DEP solid waste.

9. One on-site inspection, Routine-Dollar General #19872 (Middle Smithfield). Inspection to terminate permit coverage. Water quality inlets full of trash and need cleaning and replacement. IR 3 sent.

10. One on-site inspection, Follow up, Scotrun Estates Deerfield Way Driveway, (Pocono) - Owner was reconstructing driveway, roadside swale, and filling around home. Site lacked adequate Stabilization. Owner immediately followed up with photos. IR 2 sent.

11. One on-site inspection, Routine, Vigon Int. Inc. Warehouse (Smithfield) - E&S BMPs installed. Basin outlet structure completed. The infiltration basin appears to have intercepted ground water. IR 3 sent.

12. One on-site inspection, Routine, Schoolhouse Estates (Price) - additional homes and rain gardens have been constructed. Multiple swales still require properly installed of erosion control matting. Additional perimeter control BMPS required. IR 23 sent.

13. One on-site inspection, Routine, Kinsley Solar (Chestnuthill) - Installation of BMPs on site started prior to Pre-construction meeting. All BMPs were properly installed. Stormwater culvert lacked rock apron. IR 1 Sent w/Compliance Notice.

14. One on-site inspection, <u>Complaint</u> Lakeside Parking lot Fill Site (Hamilton) - Additional fill was added to the parking lot and a retaining wall was constructed. Site lacked temporary stabilization and E&S perimeter control BMPs were inadequately installed. IR 1 sent.
