- 13. One On-site Inspection, Final, Saylorsburg Dollar General (Ross Township) Site is stabilized and PCSM BMPs installed and maintained. Notice of Termination acknowledged with IR 8.
- 14. One On-site inspection, Routine, Kalahari Resort/Papillon & Moyer (Tobyhanna and Pocono Townships) Sediment Basin 4 being converted to stormwater. Basin 3 downstream conveyance not maintained and causing erosion. IR 59 sent.
