

# Pleasant Valley Wins Monroe County Envirothon and Moves on to Compete in the NCF-Envirothon International Competition!

On May 22, 2021 the Monroe County High School Envirothon was held with ten teams from four County schools. The teams tested their knowledge of the environment through five different series of tests: Aquatics, Soils, Forestry, and Wildlife plus this year's Current Issue; Water Resource Management: Local Control & Local Solutions.

The Reece's Pieces of Pleasant Valley High School took first place in the Monroe County High School Envirothon. The Eastern Milkshakes of Pleasant Valley High School followed behind in second, with the Backstreet Buds of Pocono Mountain East High School taking third.

The Reece's Pieces moved on to compete in the 37<sup>th</sup> Pennsylvania Envirothon state competition which was held virtually on May 10, 11, and 25, 2021. High school students from 58 Pennsylvania counties participated in this year's event. Students were tested on the same



subjects as the County competition with the top 15 scoring teams also delivering oral presentations to a panel of judges who evaluated each team on its problem-solving capabilities, oral presentation skills, and recommendations to help solve the specific environmental challenge, which related to the current environmental issue.

The Reece's Pieces team of Pleasant Valley High School took first place in the PA State Envirothon Competition and it is with great pleasure that we announce that they will be moving on to represent the state of Pennsylvania at the 32<sup>nd</sup> NCF-Envirothon virtual competition planned for July 25 – 28 hosted by Nebraska Envirothon. More than 45 teams from the United States, Canada, and China are expected to compete.

The Reece's Pieces team of Monroe County is coordinated by advisor, Maricatherine Garr. Team captain: Emma Barrett, Team members: Zachary Dooner, Reece Kresge, Megan Chechel and Benjamin Keppel.

We are extremely proud to have the Reece's Pieces representing Monroe County, Pennsylvania at this year's NCF-Envirothon International Competition and wish them the best of luck! Stay tuned to our webpage and social network for an update on how they did.

The Envirothon is sponsored by the Monroe County Conservation District, PA Envirothon Inc. and generously funded by the Kettle Creek Environmental Fund. The Envirothon was financed in part by a grant awarded to Pennsylvania Envirothon from the Community Conservation Partnership Program, using Environmental Stewardship Funds, under the administration of the Pennsylvania Department of Conservation and Natural Resources, Bureau of Recreation and Conservation. This project was also financed in part by a grant awarded to Pennsylvania Envirothon under the administration of the Shell Oil Company U.S.

## Junior Envirothon Results

The Kettle Creek Environmental Education Center hosted the Junior Envirothon competition on Monday, May 17<sup>th</sup>, for fifth and sixth graders, and Tuesday, May 18<sup>th</sup>, 2021, for seventh and eighth graders. Competing teams from area schools were tested on their knowledge of the Pocono environment at four stations—Animals, Trees, Ponds, and this year's Learning Station, Wetlands.

#### **DIRT & GRAVEL MINUTE**

News You Can Use When Maintaining Your Gravel Driveway

"What kind of stone should I put on my driveway?" is a question we hear often. We've discussed road shape and maintenance of surface aggregate previously; we will spend time talking about surface and subsurface drainage practices in future issues. But for this issue we wanted to answer the basic question and present some of the options available and their pros and cons.

Monroe County is fortunate to have very good source material for stone products. The blue limestone found along the county's southeastern ridges is very hard (durable when trafficked) and produces concrete-like aggregates (Driving Surface Aggregate-DSA). The West End offers varying types of shale products, most of which produce a very compactible, well drained base, but turn quickly to dust when trafficked. And the northern plateau region has red sandstone which varies in hardness and thus, durability.

Then there is the gradation, or stone sizing, and mixes thereof. There are two distinct stone products available at most local quarries and landscape suppliers: clean stone, similarly sized rock particles without fines, and aggregates, which are a mix of particles sizes, in some cases including smaller particles and fines. In general, clean stone is used for drainage, with visible void spaces between the particles of rock. Clean stone is also used for a base, often with a geotextile layer on top before adding an aggregate base or surface layer.

If you've ever walked on a driveway with a clean stone surface, you've noticed it is loose and does not compact well, whereas an aggregate surface is more solid and the particles are knitted together (tight). Information on various Pennsylvania aggregates can be found at the Center for Dirt and Gravel Studies under General Resources, Technical Bulletins: Aggregate 101. We will discuss the function and aesthetics of both types of stone products. Traffic loads, both weight and volume (trips per day) should be considered when choosing a driveway surface. Clean stone: Commonly in PA-1B or 2B stone (ASSHTO #67 or 57) are commonly used for driveways and walkways. Sizes range from 3/8", to 3/4" with small variations. We also see 1B used behind retaining walls as it is pourable. They work best on flatter slopes, induce little dust splatter on vehicles after a rain, and have a "clean" uniform appearance. They don't however compact well, and can present some challenges for young and older pedestrians. They are not "smooth" and can roll around underfoot. The smaller size is better than the larger for walkability. They offer a moderate wearability overall, but because they are course particles they do grind against each other under traffic and break down into dust over time.

**PennDOT 2A** Most people have heard of 2A- 2A is actually a PennDOT specified drainage aggregate, with the largest particle size passing a 2" sieve, some in between sizes, and up to 10% the size of a pencil point. Compactability is very high with 2A and it provides a smoother surface for pedestrians than clean stone. It looks pretty smooth when rolled, however the larger particles do tend to "pop out" from traffic load. It wears somewhat better than clean stone as it knits together due to the variations in particle size making it one of the best all-around driveway stones you can get.

**DSA**- Driving Surface Aggregate was developed by Penn State to provide a durable surface similar to asphalt. It has more smaller particles and fines to "cement" the aggregate than 2A has. When dry, DSA resembles concrete. It does require special maintenance, but for high volume or heavy haul roads, it will produce the least dust and long term durability. On driveway applications, it does produce a lot of dust splatter on the lower portion of vehicles but alternatively does produce a seriously stable surface for walking and driving. It needs to be paver placed, so installation costs are somewhat higher, but maintenance intervals are longer than other types of stone. Now that you have this information, check out how they look, how they perform- do they hold their shape, do they resist erosion on steep slopes, and how often do they get maintained, and how easy are they to walk? As you travel, take note of the various driveway materials folks use and the next time you have to add material to your own driveway, we hope you'll know: what kind of stone should I put on my driveway?


