

2021 MAPLE SUGARING SEASON



As fall approaches with winter soon to follow, the Meesing Sugar bush sits quiet and empty. It won't be long, however, until the EE staff heads to the Sugarbush to begin the 2021 Maple Sugaring Season.

The 2020 Maple Sugaring Season was cut a little short due to Covid-19 but we were still able to produce over 30 gallons of

sweet syrup. We started tapping trees on Feb. 10 and had a consistent run of sap up until the 10th of March when the warming weather stopped the flow. On our annual public day the 456 people that visited us that day enjoyed fresh pancakes with our syrup.

We hope you can make plans to join us this season! This will be our 44th year but due to Covid-19 it will be a little different. We will be limiting the number of people on site and following all Covid-19 safety protocols including masks at all times. We will require registration for visitors on one of three Saturdays in March the 6th, 13, and the 20th, 2021. Each day will feature a tour of the Sugar bush including stops to learn about Native American and early pioneer methods of making maple syrup, our evaporator process and methods of identifying and tapping a maple tree. Cost: \$6/adult and \$4/children under 12; all members of the EE Center and all tree sponsors attend free of charge.

Scout Groups will be allowed to register for any one of the three Saturdays. **Registration is required for any of the programs no later than the Thursday before the program.**

Dates set for group programs in the Sugarbush are Monday, February 28 through Friday, March 12. All groups interested in scheduling a tour should call the Center to set aside a time block. Each program takes 1 ½ to 2 hours and includes learning about maple sugaring from the earliest methods used by Native Americans to present day collection/evaporation techniques. The group will also tap a maple tree and take home a sample of sweet maple syrup. Cost: \$4/participant, spaces fill up fast, so please register early. The Sugarbush is located 5.5 miles north of Marshalls Creek on Creek Rd. For more information call (570)629-3061, Monday through Friday, from 8am to 4:30pm.

Sponsor a Maple Tree

In 2020, over 190 different groups, families or individuals sponsored trees in our Sugarbush. These sponsorships raised over \$4,500.00 which was used to help pay the expenses for our group tours of the Sugarbush. We are hoping that in 2021 even more people will help us by sponsoring a tree. We tap around 250 trees each year, so there are plenty available.

Conservation through Education ~ Winter 2020 Two Eagle Scout Candidates Complete Projects


Over the years the Kettle Creek Environmental Education Center has been fortunate to work with numerous Eagle Scout candidates as they completed their projects at one of our outdoor sites. These projects have provided all kinds of benefits to program participants and the wildlife that live at Kettle Creek. We had two Eagle Scout candidates working hard the last several months to complete their projects and they have done an excellent job.

Ryan Farley of Tannersville and members of Boy Scout Troop #85 have recently completed a new loop trail on the recently acquired Weiss property at the Tannersville Bog. Ryan laid out the trail that connects to the existing Fernridge Trail on Bog Road. This approximately one-mile trail travels through an oak forest along the edges of meadow habitat, maintained by The Nature Conservancy through controlled burns, and along the Bog edge itself across from the boardwalk trail system. The trail is marked with blue painted blazes and is a moderate hike with the opportunity to view a wide array of plants that inhabit forest and meadow areas. It is also a great birding spot year-round. Access can be gained by parking at the Fernridge trailhead on Bog Road, hiking the short loop trail marked with yellow blazes and branching off onto the Weiss Trail marked with blue blazes.

Cassidy Feuerstein of Pocono Lake and members of Troop #97 recently completed two projects at Kettle Creek. For her Summit Award in Venturing, she completely took apart the water garden behind the building and located the leaks that have been plaguing us for years. After finding the leaks, she replaced the liner and reconstructed the water garden itself. All the amphibians that use the garden as habitat and a place to lay eggs will now be very happy. For her Eagle Scout Award Cassidy designed and installed numerous interpretive signs around the pavilion and along Kreger Trail. These beautiful signs help to ID trees as well as provide some history about the property.

We are very grateful to both of these scouts for their hard work and we hope you get the chance to visit the trails and enjoy the hike and learning experiences along the way.

We Need Your Input!



The Monroe County Conservation District (MCCD) and Monroe County Planning Commission (MCPC) are looking for your input on managing one of our most valuable assets...storm water! That's right; storm water is an asset to us all. Properly managed it can feed our streams and groundwater supply with drinking water, sustain our Class A trout fisheries, and support our local recreation based economy. Lack of management, however, can result in degradation of our streams and rivers and impose threats to our property, infrastructure, and safety.

But managing storm water isn't really about managing water. Instead it is about managing how we develop our land that feeds our streams and rivers otherwise known as "watersheds". When land is developed and converted from forests, wetlands, and meadows to parking lots, roadways, and roof

tops, more rainfall runs off the landscape than is soaked into the ground. This can lead to increased issues with flooding and erosion of our stream banks. Additionally, it can increase the amount of pollution like sediment, road salts, oil, and litter that runs off into our streams. That is why the Conservation District is partnering with the County Planning Commission, municipalities, and other local entities on updating our existing Act 167 storm water management plans to provide a better template for new development utilizing tools called storm water best management practices or "BMPs".

What are storm water BMPs? Well, you have probably seen them around the county for quite some time; practices like retention basins and roadway swales. In many cases they also take the form of "nonstructural BMPs" that aren't so obvious. This includes things such as ordinances that protect our streamside forest buffers and natural floodplains. However, our tool box is always growing with new practices as we learn more about managing storm water, and our needs are evolving as we adjust to changing precipitation patterns and higher intensity storms. That is why we are seeking public participation in the survey below. Please make your voice heard in this public process with updating our existing storm water management plans to let us know more about your local needs!
